FLOOR CORRESPONDENCE:

Owen Gaustad reported on the Ball Park fence repair job. The cost of the repairs on the posts, how many posts he'll put in and reuse. Approximately 450 feet of fence will be repaired on the North side. Project should be complete by October.

The new ordinance book was discussed. Everyone was encouraged to reread through it. Compare it to the old ordinance and make the corrections. Chelsey Leis and John Jangula were appointed to go through the book together and report back next council meeting.

NEW BUSINESS:

Cheryl Whitesitt asked about having a Civic Saturday in the front room on September 14, 2019 @ 10 – 11:30. It was okayed by the City Council for her to do that.

MAINTENANCE DEPARTMENT:

Casey Holzwarth reported on the street repairs that were going on at Benton Street. A water way there is almost complete. Hopefully will be finished by the week of September 15.

He also asked about what was left in the budget if 9th street from Eileen Holwarths to Grau's could be repaired, also money for Gaustad's street to be paved and put in a culvert before winter. There are drainage issues that need to be addressed on those streets.

FIRE DEPARTMENT:

Angela Wolter-Meyer represented the Fire Department and was asking for a key for responders to get in Community Center and the Concession Stand at the ballpark for First responder 1st aid kits. Casey will get keys made for the Fire department. So, they have access in an emergency.

CITY CLERK

A proposed Levy resolution was made of 6% a meeting was set for September 25th at 6 for a final decision on that.

Mary Lou was asked to contact Audrey Mularie about the claim she had against the playground area being an unsafe area.

The City Clerk position was discussed, and Mary Lou agreed to stay on if she could get some extra help figuring the CTAS program so she could get the program figured out. The Council agreed to hire some extra help. Suggestions were Char Meiners.

RICK VOSHART MADE A MOTION SECONDED BY JEFF LE JEUNE TO APPROVE AND PAY THE BILLS.


Meeting was adjourned.
