

Brownsville City Council Minutes

Minutes of the regular monthly meeting of the City Council of the City of Brownsville and the Brownsville HRA including all accounts audited by said Council.

JANUARY 6, 2016

CALL TO ORDER: This regular meeting was called to order by Mayor Timothy P. Serres at 7:00 P.M.

MINUTES: AT THIS TIME COUNCIL REVIEWED THE MINUTES FROM THE DECEMBER 2, 2015 MEETING. A MOTION WAS MADE BY DAVE BRICKMAN, SECONDED BY JOE SERRES TO APPROVE THE MINUTES AS PREPARED BY THE CITY CLERK. ALL VOTED IN FAVOR, MOTION CARRIED.

FLOOR CORRESPONDENCE: A discussion was held on the North 2nd Street proposed sewer extension project. To date six residents are in favor of the proposed project.

OLD BUSINESS: Council directed Mike Moriarty to draft a letter to two residents in the city concerning the disrepair of their homes and allowing them 60 days to present the council with a plan for repairs.

City attorney Jed Hammell updated Mike Moriarty on the status of the complaint about number of dogs at the Brandon Ranzenberger residence. The papers have been served and he will be appearing in court.

- wiring at the sewer plant is shorting out, Ron has hired Dan Walcker to re-wire
- pump is burned out in Harbor Lights Addition
- manhole on far end of Harbor Lights needs to be repaired

FIRE DEPARTMENT: NO REPORT

CITY CLERK: MIKE MORIARTY presented council a report on the receipt, disbursements and balances for the year 2015.

A MOTION WAS MADE BY DAVE BRICKMAN, SECONDED BY RICK VOSHART TO ADOPT RESOLUTION # 01-06-16, DESIGNATING THE DEPOSITORIES FOR CITY MONIES FOR THE YEAR 2016 FOR THE CITY OF BROWNSVILLE AS MERCHANT'S BANK AND 4M FUND. ALL VOTED IN FAVOR, MOTION CARRIED.

AND BLUFFVIEW MANOR RENTAL RATES FOR THE YEAR 2016. ALL VOTED IN FAVOR, MOTION CARRIED.
